## 7. Safety Report - Benoit Sonrel

Benoit reported that the Hurricane engine has finally been installed, though with worldwide supply problems, we were very lucky to get the engine we ordered in January from a small dealer before our year end. The Day of the Longboat weekend went very well with excellent support from the Jericho Rescue Team. The last two events on the Penguin Cup calendar are coming up over the next two Sundays and then we'll haul Albatross out of the water, into the hangar to dry out for annual refit. Jericho Rescue Team members are encouraged to come out for training on weekends over the winter. Our first event of 2022 will be the PNWORCA on January 29.

## 8. Operations Report –Steve Irwin

Steve reported that activity has been slowing over the past month. We will be tracking usage levels using card swipes at the front gate over the winter and will be able to compare with last winter's usage rates. The stucco work approved by the board in September had to be delayed due to anticipated low temperatures in the latter half of September. We are continuing to monitor Park Board facilities and are considering ways to open our indoor showers and change rooms over the winter. Our annual winter maintenance program has commenced with interior painting. An Operations Committee Zoom meeting will be scheduled for November. The agenda will include standard and capital projects as well as planning for post Covid operations.

A Jericho Lands Group Zoom forum will take place next week to present 2 plan concept options along with 3 dimensional plan view. An estimate for number of potential project residents will be presented.
