Supplementary Sailing Instructions

The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and these supplementary sailing instructions including course diagrams.

1 Location of the Race Office and Flagpole

The race office is the JSCA office at 1300 Discovery St, Vancouver, BC. The flag pole is located along the North fence of the Jericho Sailing Centre at Ramp 2 (closest to the office).

2 Schedule of Races

2.1 Friday June 24

1100 hrs: Skippers meeting

1200 hrs: Warning signal for first of 3 scheduled races

Saturday June 25

1100 hrs: Warning signal for first of 3 scheduled races

Sunday June 26

1130 hrs: Warning signal for first of 3 scheduled races

1500 hrs: No warning signal will be made after this time

3 Marks

Marks 1, 2s, 2p, 3 & 4 will be yellow tetrahedrons.

4 Time Limits

• Mark 1 Time limit: 30 minutes

• Race Time Limit: 80 minutes

• Finishing Window: 25 minutes

5.1 Standard Sailing Instruction 5.2 is deleted.

5.2 Standard Sailing Instruction 7.2 is changed to: The course diagrams follow Supplementary

SI 5. They show the courses, the order in which marks are to be passed, and the side on which each mark is to be left.

- 5.3 Standard Sailing Instruction 9.1 is changed to: The Races will be started by using RRS 26 with the warning signal made three (3) minutes before the start.
- 5.4 Standard Sailing Instruction 9.2 is changed to: The start line will be between an orange shape on the committee boat and a staff displaying a red flag.
- 5.5 Standard Sailing Instruction 11.1 is changed to: The Finish line will be between an orange shape on the committee boat and a staff displaying a blue flag.
- 5.6 Standard Sailing Instruction 13.1 is changed to: Hearing requests and requests for redress must be filed online using the form provided at <https://www.racingrulesofsailing.org/events/4335> within the protest time limit.
