4. PRESIDENT'S REPORT – Chris Stairs

Mike presented the September budget report which completes reporting for the fiscal year. Mike noted that our energy cost was significantly over budget due to the City replacing a faulty meter which the budget had been based on. Benoit reported on a more active year for the Jericho Rescue Team supporting a full event calendar after having the first annual training course since 2019. There will be more winter training sessions over the off season. Benoit reminded everyone to dress appropriately for cold water conditions.

9. OPERATIONS COMMITTEE REPORT – Mike Cotter for Steve Irwin

Mike reported that staff is preparing to commence our annual winter maintenance schedule which includes interior painting; door/window hardware and furniture maintenance, as well as dolly fleet refit. We are expecting the receive our energy study report this month and will review it at the first Operations meeting of the new board for opportunities to reduce our energy costs.

10. GENERAL MANAGER'S REPORT - Mike Cotter

Regular school programs all wrapped up for the season. The Galley will be open weekends until the end of October. Currently in discussions with two clubs which are interested in becoming affiliated with JSCA: The Vancouver Lifeguard Association and the Lifesaving Sport Club. They each may approach the board with proposals in the coming months.
