Amendment 1 – Modification to the Notice of Race

The start time on Sunday has been modified to 12:00. Attached is the modified Notice of Race with the modification highlighted in green.

Modified Notice of Race

1 Rules

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing (RRS), the prescriptions of Sail Canada, the Class Rules of the World Tasar Class Association, except as any of these are changed by these sailing instructions or by the North American Tasar Association.
- 1.2 [DP] [RRS 40](#) and the preamble to [Part IV](#) are amended so that competitors shall wear personal flotation devices at all times while on the water except briefly while changing or adjusting clothing or personal equipment. Wet suits or dry suits do not qualify as personal flotation devices.
- 1.3 [RRS 60.4\(a\)\(2\)](#) is changed as follows: (2) if it alleges a breach of rule of part 2 or rule 31 and if from a boat that was not involved in, and did not see, the incident, or.

Sailing Instructions

- 2.1 The sailing instructions will be available on or before 12:00h on September 5th, 2026 on the Jericho Sailing Centre website and on the notice board in the foyer of the Jericho Sailing Centre, 1300 Discovery St, Vancouver BC.

3 Communication

- 3.1 The official notice board will be in the foyer of the Jericho Sailing Centre. Results will be posted at <https://www.jracing.org/>.
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 Eligibility and Entry

- 4.1 The event is open to all boats of the International Tasar Class.
- 4.2 Skippers wishing to register boats in this event must be members of Good Standing of a recognized yacht/sailing club/association or National Authority.
- 4.3 All competitors must sign the current member / guest waiver at <https://www.waiverfile.com/b/jsca/Waiver.aspx>. Current JSCA members should have signed already. Parents and / or Legal Guardians must sign for under-age sailors.
- 4.4 Boats may enter the event by registering online at <https://www.jracing.org/> and selecting the event Tasar BC Championship.
- 4.5 To be considered an entry in the event, a boat shall complete all registration and waiver requirements.

5 Fees

- 5.1 Entry fee: \$25 per boat.
- 5.2 These fees include all racing fees and temporary storage for visiting boats. Payment can be made by Interac money transfer to: accounts@jsca.bc.ca (please include a note with the competitor's names and sail number) or in person by cash on the Saturday morning of the regatta.

6 Schedule

- 6.1 Registration:

Saturday September 5th From 11:00 to 12:00 at the Jericho Sailing Centre

6.2 Competitors Meeting:

Saturday September 5th 12:00 at the front of the Jericho Sailing Centre

6.3 Dates of Racing:

Saturday September 5th 13:00 (Scheduled Time of First Warning)

Sunday September 6th 12:00 (Scheduled Time of First Warning)

7 Equipment Inspection

7.1 Each entrant is responsible for ensuring that their boat (hull, sails and rigging) conforms with class rules and regulations.

7.2 Boats may be inspected at any time.

8 Venue

8.1 The event venue is the Jericho Sailing Centre, 1300 Discovery St, Vancouver, BC.

8.2 The racing area is English Bay.

9 Courses

9.1 Courses will be windward-leeward, triangle or variations thereof. Courses will be specified in detail in the Sailing Instructions.

10 Scoring

10.1 Two (2) races are required to be completed to constitute a series.

10.2 The low point system as described in [RRS Appendix A, Section A4](#) is in effect

10.3 (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.

(b) When from 5 to 9 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

11 Risk Statement

11.1 [RRS 3](#) states: *'The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.'* By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

11.2 The organizing authority, the Jericho Sailing Centre Association, its staff and volunteers and sponsors will not accept any liability for material damage or personal injury or death sustained in conjunction with, prior, to, during or after the 2025 Tasar BC Championships.

11.3 It is recommended that competitors carry adequate liability insurance.

12 Rights to Use Names and Likenesses

12.1 By participating in the Tasar BC Championships, competitors automatically grant to the organizing authority the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recordings, and

other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
